## Part 1 Preliminary

### 1 Short title

This regulation may be cited as the *Water and Other Legislation Amendment Regulation (No. 1) 2017*.

## Part 2 Amendment of Valuers Registration Regulation 2013

### 2 Regulation amended

This part amends the *Valuers Registration Regulation 2013*.

### 3 Amendment of s 2 (Code of professional conduct)

Section 2(6), definition *API code*—

**5 Amendment of s 25 (Prescribed activities—Act, s 101)**

Section 25(2), ‘applies.’—

*omit, insert—*

applies, unless the water is taken by a person who holds—

- (a) a resource operations licence for the water supply scheme; or
- (b) an interim resource operations licence for the water supply scheme; or
- (c) a distribution operations licence for the water supply scheme.

**6 Replacement of s 58 (Applying for a seasonal water assignment)**

Section 58—

*omit, insert—*

**58 Applying for a seasonal water assignment**

- (1) The holder of a water allocation may apply to the chief executive for a seasonal water assignment for the water allocation for the water year in which the application is made.
- (2) The holder of a seasonal water assignment notice for a water allocation may apply to the chief executive for a seasonal water assignment for the seasonal water assignment notice for the water year in which the application is made.
- (3) An application under subsection (1) or (2) must be—
  - (a) in the approved form; and
  - (b) accompanied by the application fee stated in schedule 12.

**8 Amendment of s 60 (Conditions of seasonal water assignment notice)**

(1) Section 60—

*insert—*

(aa) if the applicant for the seasonal water assignment is the holder of a seasonal water assignment notice (the *existing notice*) for the water allocation—the conditions to which the existing notice is subject; and

(2) Section 60(aa) and (b)—

*renumber* as section 60(b) and (c).
