Part 1 Preliminary

1 Short title

This regulation may be cited as the *Liquor (Kowanyama) Amendment Regulation 2020*.

2 Commencement

- (1) Part 3 commences on 1 January 2021, immediately after the commencement of the *Liquor (Kowanyama and Pormpuraaw) Amendment Regulation 2020*, part 3.
- (2) Part 4 commences on 1 July 2021.

3 Regulation amended

This regulation amends the *Liquor Regulation 2002*.

5 **Insertion of new s 37**

After section 36P—

37 Exemption for particular community liquor permit in Kowanyama Shire Council

- (1) This section applies to any application for a community liquor permit made by the Kowanyama Sport and Recreation Association Inc, between 1 January 2021 and 30 June 2021, for an event in the community area of the Kowanyama Shire Council.
- (2) Despite section 36D, no fee is payable for the application under the Act.
- (3) This section expires on 30 June 2021.

6 **Amendment of sch 1G (Kowanyama)**

Schedule 1G, section 2—

2 Prescribed quantity

The prescribed quantity of liquor for each restricted area is—

- (a) for liquor in which the concentration of alcohol is less than 4%—2.25L; or
- (b) for any other liquor—zero.
