(2A) The meeting may be held, and eligible persons may take part in the meeting by, using any technology allowing reasonably contemporaneous and continuous communication between persons taking part in the meeting.

*Examples of use of technology—*

teleconferencing, videoconferencing

(2B) A person who takes part in the meeting under subsection (3) is taken to be present at the meeting.
