(1) For section 234(2) of the Act, the prescribed

- (a) starts on the day the director receives a finalised report about the pathological examination; and
 - (b) ends 30 days after the day mentioned in paragraph (a).
- (2) For section 234A(2) of the Act, the prescribed period—
- (a) starts on the day the director receives a finalised report about the diagnostic imaging procedure; and
 - (b) ends 30 days after the day mentioned in paragraph (a).
- (3) For section 234B(2) of the Act, the prescribed period—
- (a) starts on the day the director becomes aware of the cancer diagnosis; and
 - (b) ends 30 days after the day mentioned in paragraph (a).
- (4) For section 234C(2) of the Act, the prescribed period—
- (a) starts on the day the cancer-related treatment is provided; and
 - (b) ends 120 days after the day the cancer-related treatment is completed, discontinued or otherwise ends.
- (5) For section 234D(2) of the Act, the prescribed period—
- (a) starts on the day the director becomes aware of the death; and
 - (b) ends 30 days after the day mentioned in paragraph (a).
