## **Part 2                      Some basic concepts** 20 **for AFAD** 21

### **232 What is *AFAD residential land*** 22

*AFAD residential land* is land in Queensland— 23

- (a) that is, or will be, solely or primarily used 24  
for residential purposes; and 25
- (b) to which any of the following applies— 26
  - (i) on the land there is, or will be 27  
constructed, a building designed or 28  
approved by a local government for 29  
human habitation by a single family 30  
unit; 31

- 
- (ii) on the land there is a building that a person will refurbish, renovate or extend so it becomes a building mentioned in subparagraph (i);
  - (iii) the land is a lot on which there is a building or a part of a building that, for the separate area the lot comprises, is designed or approved by a local government for human habitation by a single family unit;
  - (iv) the land will be a lot on which there is a building or a part of a building that, for the separate area the lot comprises, is designed or approved by a local government for human habitation by a single family unit;
  - (v) the land is a lot on which there will be a building or a part of a building that, for the separate area the lot comprises, is designed or approved by a local government for human habitation by a single family unit;
  - (vi) a person is undertaking, or will undertake, development of the land so it becomes land mentioned in any of subparagraphs (i) to (v).

### **233 Who is an *acquirer***

- (1) For the purpose of imposing AFAD relating to transfer duty on a dutiable transaction, a person is an *acquirer* if the person is—
  - (a) for a dutiable transaction mentioned in section 9(1)(a) or (b)—a transferee of the dutiable property under the transaction; or
  - (b) for a dutiable transaction mentioned in section 9(1)(c) to (e)—a person who, under

**234 Who is a foreign person** 23

Each of the following is a **foreign person**— 24

- (a) a foreign individual; 25
- (b) a foreign corporation; 26
- (c) the trustee of a foreign trust. 27

**235 Who is a foreign individual** 28

A **foreign individual** is an individual other than 29  
an Australian citizen or permanent resident. 30

**238 Who are *related persons*** 4

Persons are *related persons* if they are— 5

- (a) related persons under section 61; or 6
- (b) partners in a partnership. 7

**239 Property held by partnership or trust** 8

A reference in this chapter to a partnership or trust 9  
holding property is a reference to the holding of 10  
the property by the partners for the partnership or 11  
trustees on trust. 12

**Part 3 Liability for AFAD** 13

**240 Conditions for imposing AFAD** 14

AFAD is imposed on a relevant transaction if, at 15  
the time the liability for transfer duty, landholder 16  
duty or corporate trustee duty on the transaction 17  
arises— 18

- (a) the property condition under section 241 19  
applies; and 20
- (b) an acquirer under the transaction is a foreign 21  
person. 22

**241 Property condition for imposing AFAD** 23

- (1) This section states the property condition for 24  
section 240(a). 25
- (2) If the relevant transaction is a dutiable 26

- (a) for a dutiable transaction mentioned in 2

    - (i) AFAD residential land; or 7

    - (ii) has an indirect interest in dutiable 27  
property that is AFAD residential land. 28
- (3) If the relevant transaction is a relevant 29  
acquisition, the property condition is that— 30
- (a) for landholder duty—the landholder has 31  
land-holdings that include AFAD residential 32  
land; or 33

- 
- (b) for corporate trustee duty—the dutiable 1  
property held on trust by the corporate 2  
trustee, or in which the corporate trustee has 3  
an indirect interest that is held on trust, 4  
includes AFAD residential land. 5

## **Part 4                      Calculating AFAD** 6

### **242 Definitions for pt 4** 7

In this part— 8

*foreign acquirer* means an acquirer who is a 9  
foreign person. 10

*foreign acquirer's interest*, under a relevant 11  
transaction, means the proportion that the share of 12  
the foreign acquirer under the transaction bears to 13  
the total of the shares of all acquirers under the 14  
transaction. 15

### **243 Non-application of concessions** 16

The following provisions do not apply to the 17  
calculation or payment of AFAD imposed under 18  
this chapter— 19

- chapter 2, part 9 20

### **244 AFAD for transfer duty** 23

- (1) This section applies if, under part 3, AFAD 24  
relating to transfer duty is imposed on a dutiable 25  
transaction. 26
- (2) AFAD is imposed at the rate of 3% on the 27  
following amount— 28

  - (i) to the extent the partnership acquisition, trust acquisition or trust surrender relates to AFAD residential land; and 15

**245 AFAD for landholder duty** 22

- (1) This section applies if, under part 3, AFAD relating to landholder duty is imposed on a relevant acquisition. 23  
24  
25
- (2) AFAD is imposed on a relevant acquisition made in a private landholder at the rate of 3% on the dutiable value of the acquisition— 26  
27  
28
  - (a) to the extent the dutiable value relates to land-holdings of the landholder that are AFAD residential land; and 29  
30  
31
  - (b) to the extent of the foreign acquirer’s interest in the relevant acquisition. 32  
33
- (3) AFAD is imposed on a relevant acquisition made 34

---

in a public landholder, to the extent of the foreign  
acquirer's interest in the relevant acquisition, in  
the amount calculated in the way landholder duty  
is calculated under section 179A but with the  
changes stated in subsection (4).

- (4) For subsection (3), in relation to the calculation of  
transfer duty as mentioned in section 179A—
- (a) the dutiable transaction mentioned in that  
section is treated as being limited to the  
transfer of the AFAD residential land; and
- (b) the amount of transfer duty that would be  
imposed on the transaction as mentioned in  
that section is calculated at the rate of 3%.

#### **246 AFAD for corporate trustee duty**

- (1) This section applies if, under part 3, AFAD  
relating to corporate trustee duty is imposed on a  
relevant acquisition.
- (2) AFAD is imposed at the rate of 3% on the dutiable  
value of a relevant acquisition—
- (a) to the extent the dutiable property held on  
trust by the corporate trustee, or in which  
the corporate trustee has an indirect interest  
that is held on trust, is AFAD residential  
land; and
- (b) to the extent of the foreign acquirer's  
interest in the relevant acquisition.

## **Part 5 Reassessments**

### **246A Reassessment if corporation or trust becomes foreign**

- (1) This section applies if AFAD is not imposed on a  
relevant transaction only because an acquirer

- under the transaction is not a foreign person. 1
- (2) The commissioner must make a reassessment 2  
under subsection (3) if— 3
- (a) within 3 years after the time the liability for 4  
transfer duty, landholder duty or corporate 5  
trustee duty on the transaction arose, a 6  
corporation that was an acquirer under the 7  
transaction becomes a foreign corporation; 8  
or 9
- (b) both of the following apply— 10
- (i) a person was an acquirer under the 11  
transaction in the person’s capacity as 12  
trustee; 13
- (ii) within 3 years after the time the 14  
liability for transfer duty, landholder 15  
duty or corporate trustee duty on the 16  
transaction arose, the trust becomes a 17  
foreign trust. 18
- (3) The commissioner must make a reassessment to 19  
impose AFAD on the transaction as if, at the time 20  
the liability for transfer duty, landholder duty or 21  
corporate trustee duty on the transaction arose, the 22  
acquirer was a foreign person. 23
- (4) Within 28 days after an event mentioned in 24  
subsection (2)(a) or (b)(ii) happens, the 25  
corporation or trustee of the trust must— 26
- (a) give notice in the approved form to the 27  
commissioner; and 28
- (b) ensure the instruments required for the 29  
assessment of duty on the transaction are 30  
lodged for a reassessment of duty on the 31  
transaction. 32

- (e) for a dutiable transaction mentioned in section 9(1)(i) that is a trust acquisition—the trustee of the trust in which the trust acquisition is made;
- (f) for a dutiable transaction mentioned in section 9(1)(i) that is a trust surrender—
  - (i) the trustee of the trust in which the trust interest is surrendered; or
  - (ii) if there is no longer a trustee as a result of the surrender, the person who holds the AFAD residential land as a result of the surrender.
- (3) The charge has priority over all other encumbrances over the chargee’s interest in the land other than a charge under section 156P.
- (4) Subsection (3) applies—
  - (a) whether the other encumbrances over the chargee’s interest in the land—
    - (i) are registered or unregistered; or
    - (ii) were created before or after the charge arises under subsection (2); and
  - (b) despite the *Land Title Act 1994*, part 3, divisions 2 and 2A.
- (5) The commissioner may lodge, under the Administration Act, part 4, division 5, a request to register the charge on the land that is the subject of the transaction.
