- (a) this Act;

- (c) the *Motor Accident Insurance Act 1994*.

## 70 What is a taxi service

- (1) A *taxi service* is a public passenger service for a journey that starts in Queensland—
  - (a) provided by the hire of—
    - (i) a motor vehicle that has not more than 12 seating positions, including the driver's position; and

- (ii) a person to drive the vehicle; and 1
- (b) under which the vehicle plies or stands for 2  
hire by members of the public in a public 3

available for hire on-the-spot by members of the 9

drive a motor vehicle to provide a booked hire 16  
service by accepting the booking. 17

- (3) A person arranges a booking for another person to 18  
drive a motor vehicle to provide a booked hire 19  
service— 20

- (a) if the person uses a booking system that 21  
requires the other person to accept the 22  
booking—by arranging for the booking to 23  
be accepted by the other person; or 24

- (b) otherwise—by assigning the booking to the 25
