This Act may be cited as the <i>Victims' Commissioner and Sexual Violence Review Board Act 2024</i> .	5 6

The main purposes of this Act are—	10
(a) to establish the Victims' Commissioner to promote and protect victims' rights; and	11 12
(b) to declare a charter of rights for affected victims; and	13
(c) to establish the Sexual Violence Review Board to identify and review systemic issues in relation to the reporting, investigation and prosecution of sexual offences.	14 15 16 17

(1) This Act binds all persons, including the State.	19
(2) Nothing in this Act makes the State liable to be prosecuted for an offence.	20 21

<b>6</b>	<b>Meaning of <i>victim</i> and <i>harm</i></b>	5
(1)	A <i>victim</i> is a person who suffers harm—	6
(a)	because a criminal offence is committed against the person; or	7 8
(b)	because the person is a family member or dependant of another person who suffers harm because a criminal offence is committed against the other person; or	9 10 11
(c)	as a direct result of intervening to help another person who suffers harm or dies because a criminal offence is committed against the other person; or	12 13 14
(d)	because the person is a witness of a criminal offence committed against another person.	15 16
(2)	A person who is a family member or dependant of another person is a <i>victim</i> if the other person dies because a criminal offence is committed against the other person.	17 18 19
(3)	Subsection (4) applies if a victim mentioned in subsection (1)(a) is pregnant when the criminal offence is committed and, as a result of the commission of the criminal offence—	20 21 22
(a)	the person sustains a bodily injury that results in the destruction of the life of the person's unborn child; or	23 24

- 10 Powers** 15
- (1) The commissioner has the power to do all things necessary or convenient to be done in performing the commissioner's functions under this Act or another Act. 16  
17

  - (2) Without limiting subsection (1), the commissioner may engage appropriately qualified persons to give advice to the commissioner relevant to the commissioner's functions. 19  
20  
21
- 11 Commissioner to act independently and in the public interest** 22  
23
- (1) In performing the commissioner's functions, the commissioner must act independently and in the public interest, having regard to all of the following— 24  
25  
26
    - (a) the vulnerability of victims of sexual violence or domestic violence; 27  
28
    - (b) the vulnerability of Aboriginal and Torres Strait Islander victims; 29  
30

- 
- (c) victims who have characteristics that may make them particularly vulnerable to harm. 1  
2  
*Examples of victims who may be particularly vulnerable to harm—* 3
- women 4
  - children 5
  - victims from a culturally or linguistically diverse background 6  
7
  - victims with disability 8
  - victims who are lesbian, gay, bisexual, transgender or intersex 9  
10
  - elderly victims 11

(2) Without limiting subsection (1), the commissioner is not subject to direction by any person, including the Minister, about the way in which the commissioner's functions are to be performed. 12  
13  
14  
15

(3) In this section— 16  
*sexual violence* means an act or omission constituting a sexual offence. 17  
18

## 12 Relationship to functions under other particular laws 19

The commissioner must ensure that the commissioner's functions are performed in a way that does not duplicate the performance of a function of an entity under this Act or any of the following Acts— 20

- (j) the *Ombudsman Act 2001*; 3
- (k) the *Penalties and Sentences Act 1992*; 4

- (m) the *Public Guardian Act 2014*; 6
- (n) the *Victims of Crime Assistance Act 2009*. 7

To avoid duplication, the commissioner may coordinate the conduct of 10  
a review under section 9(a) with a person performing a function under 11  
another Act mentioned in this section. 12

### **13 Commissioner not a statutory body for particular Acts** 13

It is declared that the commissioner is not a statutory body for 14  
the *Financial Accountability Act 2009* or the *Statutory Bodies* 15  
*Financial Arrangements Act 1982*. 16

## **Division 2 Appointment** 17

### **14 Appointment of commissioner** 18

- (1) The commissioner is appointed by the Governor in Council on 19  
the recommendation of the Minister. 20
- (2) The Minister may recommend a person for appointment as 21  
commissioner only if the Minister is satisfied— 22
  - (a) the person is eligible for appointment; and 23
  - (b) the person is appropriately qualified to work with 24  
victims and to perform the commissioner's functions 25  
under this Act effectively and efficiently. 26

- (3) A person is not eligible for appointment as commissioner if the person is disqualified from becoming the commissioner under section 15. 1  
2  
3
- 15 Disqualification from appointment** 4
- A person is disqualified from becoming or continuing as the commissioner if— 5  
6
- (a) the person has a conviction, other than a spent conviction, for an indictable offence; or 7  
8
- (b) the person is an insolvent under administration; or 9
- (c) the person is disqualified from managing corporations because of the Corporations Act, part 2D.6; or 10  
11
- (d) the person does not consent to the Minister requesting a report about the person's criminal history under section 23. 12  
13  
14
- 16 Term of appointment** 15
- (1) The commissioner holds office for the term stated in the commissioner's instrument of appointment. 16  
17
- (2) The stated term must not be more than 5 years. 18
- (3) The commissioner may be reappointed. 19
- 17 Conditions of appointment** 20
- (1) The commissioner is to be paid the remuneration and allowances decided by the Governor in Council. 21  
22
- (2) The commissioner holds office on the terms and conditions, not provided for by this Act, decided by the Governor in Council. 23  
24  
25
- (3) The commissioner is appointed under this Act and not under the *Public Sector Act 2022*. 26

- (b) allow the person a reasonable opportunity to make representations to the Minister about the information. 9

- 24 Changes in criminal history must be disclosed 11**
- (1) This section applies if a person who is the commissioner is charged with or convicted of an indictable offence. 12

- (2) The person must, unless the person has a reasonable excuse, immediately give notice of the charge or conviction to the Minister under this section. 14

- Maximum penalty—100 penalty units. 17
- (3) The notice must include— 18
- (a) the existence of the charge or conviction; and 19
- (b) for a charge— 20
- (i) details adequate to identify the alleged offence; 21  
and 22
- (ii) when the offence was alleged to have been committed; and 23  
24
- (c) for a conviction— 25
- (i) when the offence was committed; and 26
- (ii) details adequate to identify the offence; and 27
- (iii) the sentence imposed on the person. 28

## **Part 3 Access to information 3**

### **29 Information must be given to the commissioner 4**

(1) This section applies if the commissioner considers a 5  
prescribed entity has information necessary for identifying 6  
and reviewing systemic issues under section 9(a). 7

(2) The commissioner may, by notice, ask the entity to give to the 8  
commissioner information mentioned in subsection (1), 9  
including confidential information, held by the entity or to 10  
which the entity has access. 11

(3) The notice must state— 12

(a) the information required by the commissioner; and 13

(b) the reasons why the information is required; and 14

(c) the purpose for which the information will be used; and 15

(d) a reasonable period for the entity to comply with the 16  
notice. 17

(4) The entity must comply with the notice, unless the entity has a 18  
reasonable excuse. 19

Maximum penalty—100 penalty units. 20

*Note—* 21

See section 99 for protection from liability for persons complying with 22  
an information request. 23
