**The Parliament of Queensland enacts—** 1

**Part 1 Preliminary** 2

**Clause 1 Short title** 3

This Act may be cited as the *Summary Offences (Prevention of Knife Crime) and Other Legislation Amendment Act 2023*. 4

**Clause 2 Commencement** 6

This Act commences on a day to be fixed by proclamation. 7

**Part 2 Amendment of Police Powers and Responsibilities Act 2000** 8

This part amends the *Police Powers and Responsibilities Act 2000*. 11

**43A Unlawful sale of controlled items or spray paint to minors** 17  
18

(1) This section applies if— 19

(a) a police officer— 20

- 
- (i) observes a person being sold a thing that the officer reasonably suspects is a controlled item or spray paint; or 1  
2  
3
- (ii) reasonably suspects a person has just been sold a controlled item or spray paint; and 4  
5  
6
- (b) the officer reasonably suspects the person is under 18 years. 7  
8
- (2) The police officer may— 9
- (a) ask the person to show acceptable evidence of age of the person; and 10  
11
- (b) require the person to produce the thing sold to the person. 12  
13
- (3) The police officer may seize the thing if— 14
- (a) the person— 15
- (i) refuses, or is unable, to show acceptable evidence of age of the person; or 16  
17  
18
- (ii) shows acceptable evidence of age showing the person is under 18 years; and 19  
20  
21
- (b) the officer reasonably suspects the thing is evidence of an offence against the *Summary Offences Act 2005*, section 19G, 19I, 23B or 23C. 22

- (4) In this section— 26
- acceptable evidence of age*** see the *Summary Offences Act 2005*, schedule 2. 27  
28
- controlled item*** see the *Summary Offences Act 2005*, section 19E. 29  
30
- spray paint*** see the *Summary Offences Act 2005*, schedule 2. 31

<b>spear</b> means a thing designed for use as a spear.	18
<i>Example—</i> a thing designed for spearing fish	19 20

<b>19F Meaning of sell for division</b>	22
(1) This section applies for the application, to this division, of the definition <i>sell</i> in the dictionary.	23 24
(2) A person does not keep or expose for sale or offer to sell a controlled item to a minor only because the person keeps or exposes for sale or offers to sell controlled items to the public generally.	25 26 27 28
<b>19G Sale of controlled items to minors</b>	29
(1) A person must not sell a controlled item to a	30

minor.	1
Maximum penalty—	2
(a) for a first offence—140 penalty units; or	3
(b) for a second offence—280 penalty units; or	4
(c) for a third or later offence—420 penalty units.	5 6
(2) An employee who sells a controlled item to a minor in the course of their employment can not be prosecuted under this section.	7 8 9
<i>Note—</i>	10

(3) It is a defence to a charge of an offence against subsection (1) for the person to prove—	12 13
(a) the person, or an employee of the person, required the minor to produce acceptable evidence of age; and	14 15 16
(b) the minor produced acceptable evidence of age, or purported acceptable evidence of age, showing the minor was not a minor; and	17 18 19 20
(c) the person or employee had no reason to believe the evidence was false.	21 22
<b>19H Commercial sellers must instruct employees about sale of controlled items</b>	23 24
A commercial seller who is an employer must do the following in relation to each employee of the seller—	25 26 27
(a) instruct the employee—	28
(i) not to sell a controlled item to a minor in any circumstances, even if the sale is for, or is claimed to be for, an adult; and	29 30 31 32

- (ii) to sight acceptable evidence of age for a person before selling a controlled item to the person, unless satisfied the person is an adult; 1

  - (b) warn the employee that, if the employee disregards the instructions mentioned in paragraph (a) and sells a controlled item to a minor, the employee commits an offence against section 19I; 5  
6

  - (c) obtain written acknowledgement by the employee that the employee received the instructions and warning mentioned in paragraphs (a) and (b). 10

- Maximum penalty—40 penalty units. 14

**19I Sale by employees of controlled items to minors** 15  
16

- (1) This section applies to an employee if a commercial seller who is an employer has complied with section 19H in relation to the employee. 17  
18  
19  
20
- (2) The employee must not, in the course of their employment, sell a controlled item to a minor. 21  
22  
Maximum penalty— 23
  - (a) for a first offence—20 penalty units; or 24
  - (b) for a second or later offence—40 penalty units. 25  
26
- (3) It is a defence to a charge of an offence against subsection (1) for the employee to prove— 27  
28
  - (a) the employee, their employer or another employee of their employer required the minor to produce acceptable evidence of age; and 29  
30

- (b) the minor produced acceptable evidence of age, or purported acceptable evidence of age, showing the minor was not a minor; and 1

- (c) the employee, employer or other employee had no reason to believe the evidence was false. 5

- (4) For this section, it does not matter if the commercial seller who complied with section 19H in relation to the employee is their employer at the time the employee sells the controlled item to the minor. 8

- 19J Application of Anti-Discrimination Act 1991, s 46** 13  
14
- For the *Anti-Discrimination Act 1991*, section 46, a person (the *seller*) is not to be taken to discriminate against another person only because the seller refuses to sell a controlled item to the other person because of section 19G(1) or 19I(2). 15  
16  
17  
18  
19
- 19K Commercial sellers must display prohibition signs** 20  
21
- (1) A commercial seller must display prohibition signs at the seller's retail outlet under this section. 22  
23  
Maximum penalty—20 penalty units. 24
- (2) If any controlled items are displayed at the outlet, a prohibition sign must be displayed— 25  
26
- (a) at each place where a controlled item is displayed at the outlet, so the sign is clearly visible to a person viewing the displayed item; or 27  
28  
29  
30
- (b) at each point of sale at the outlet, so the sign is clearly visible to a person purchasing a controlled item. 31  
32  
33

- 
- (3) If no controlled items are displayed at the outlet, a prohibition sign must be displayed at each point of sale at the outlet, so the sign is clearly visible to a person purchasing a controlled item. 1  
2  
3  
4
- (4) Each prohibition sign must comply with the requirements prescribed by regulation. 5  
6
- (5) In this section— 7
- point of sale* means a counter or similar fixture where a controlled item may be sold. 8  
9
- prohibition sign* means a sign about the sale of controlled items to minors. 10  
11
- retail outlet* means premises where controlled items are available for sale to the public. 12  
13

**19L Commercial sellers must secure particular controlled items** 14  
15

- (1) This section applies if a commercial seller has in their possession a controlled item that is any of the following— 16  
17  
18
- (a) a dagger that is a double-edged blade; 19
- (b) a knife with a blade at each end; 20
- (c) a sword, machete or axe; 21
- (d) a sickle or scythe; 22
- (e) a spear gun; 23
- (f) a spear; 24
- (g) a bladed item prescribed by regulation. 25
- (2) The commercial seller must ensure the controlled item is securely stored at all times except when a person is in physical possession of the item. 26  
27  
28
- Maximum penalty—50 penalty units. 29
- (3) In this section— 30

- securely stored* means— 1
- (a) stored in a locked room, cage, cabinet or 2  
container; or 3
  - (b) securely tethered. 4

**19M Prohibited sales of controlled items** 5

- (1) A person must not— 6
  - (a) sell a controlled item with features that 7  
contravene this section; or 8
  - (b) sell a controlled item in a way that 9  
contravenes this section. 10

Maximum penalty—25 penalty units. 11

- (2) The features of a controlled item, or the way it is 12  
sold, must not— 13
  - (a) indicate or suggest the item is— 14
    - (i) suitable for combat; or 15
    - (ii) intended to be used for violence, 16  
whether actual or threatened, against a 17  
person or fictional creature (for 18  
example, a zombie); or 19
  - (b) be likely to stimulate or encourage violent 20  
or criminal behaviour that involves using the 21  
item. 22

- (3) A reference in this section to the features of a 23  
controlled item, or the way it is sold, includes a 24  
reference to the use of— 25
  - (a) images, words or markings on the item, its 26  
packaging or an associated item; or 27
  - (b) images or words in an advertisement for the 28  
item. 29

*Examples of images, words or markings—* 30

- a depiction of blood or a skull 31
