# Fisheries (Coral Reef Fin Fish) Quota Declaration 2015

## Part 1 Preliminary

### 1 Short title

This quota declaration may be cited as the *Fisheries (Coral Reef Fin Fish) Quota Declaration 2015*.

### 2 Commencement

Part 2 commences on 1 July 2015.

## Part 2 Annual quota

### 3 Annual quota for reef line commercial fishery—Act, s 44

(1) For a line year—

- (a) the annual quota of regulated coral trout that may be taken from the reef line commercial fishery under all CT line units is 917t; and
- (b) the annual quota of redthroat emperor that may be taken from the reef line commercial fishery under all RTE line units is 610.88t; and
- (c) the annual quota of other regulated coral reef fin fish that may be taken from the reef line commercial fishery under all OS line units is 955.597t.
