1 Short title

This regulation may be cited as the *Royal National Agricultural and Industrial Association of Queensland Regulation 2010*.

2 Prescribed land—Act, s 17D

- (1) For the Act, section 17D, the following land is prescribed—
- (a) lot 102 on SP277762 situated in the County of Stanley, containing an area of 0.2174ha;
 - (b) lot 703 on SP288048 containing an area of 6.974ha;
 - (c) lot 704 on SP288049 containing an area of 3.968ha;
 - (d) lot 709 on SP238200 situated in the County of Stanley containing an area of 0.6273ha;
 - (e) lot 800 on SP288047 containing an area of 1.417ha;
 - (f) lot 801 on SP288047 containing an area of 0.045ha;
 - (g) lot 802 on SP288047 containing an area of 0.1808ha;
 - (h) lot 803 on SP288047 containing an area of 0.1068ha.
- (2) A plan mentioned in this section 2 with a number beginning with SP is a plan held by the department administering the *Land Title Act 1994* and available for inspection by members of the public.
