# Acquisition of Land Regulation 2014

## 1 Short title

This regulation may be cited as the *Acquisition of Land Regulation 2014*.

## 2 Commencement

This regulation commences on 1 September 2014.

## 3 Fee—Act, s 9

The fee payable for an application under section 9 of the Act is—

- (a) if the application relates to only 1 parcel of land—\$186.00; or
- (b) if the application relates to more than 1 parcel of land—\$186.00 plus \$55.15 for each additional parcel of land.

## 4 Repeal

The Acquisition of Land Regulation 2003, SL No. 190 is repealed.
